ORDINANCE NO. 5028 Series of 2022

AUTHOR: HON. HUNYN C. ABU

AN ORDINANCE INCREASING THE MONTHLY MINIMUM WAGE OF COMMUNITY ALTERNATIVE LEARNING SYSTEM IMPLEMENTORS TO THREE THOUSAND FIVE HUNDRED PESOS (P3,500.00).

WHEREAS, Article II, Section 9 of the 1987 Philippine Constitution provides that "The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all.";

WHEREAS, this ordinance aims to increase the minimum monthly salary of Community Alternative Learning System (ALS) Implementors from Php2,750.00 to P3,500.00 per month;

WHEREFORE by authority of Section 16 and 458 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, be it ordained by the Sangguniang Panlungsod of Cotabato City in a regular session assembled, that:

- SECTION 1. DECLARATION OF POLICY. It is hereby declared the policy of the State to ensure that education is given the highest priority in governance, and that teaching will attract and retain its rightful share of the best available talents by means of adequate remuneration and other means of job satisfaction. In the formulation of decisions with regard to educational reforms, the State shall likewise hold paramount the protection and promotion of the right of the citizens to quality education at all levels and the rights of education workers to humane conditions of work and a living wage.
- **SECTION 2.** COVERAGE. This ordinance shall cover all Community Alternative Learning System (ALS) Implementors holding a Contract of Service from July 1, 2022 to December 31, 2022.
- **SECTION 3.** *PRIORITY IN BUDGET ALLOCATION.* The City Government of Cotabato shall appropriate such amount as may be necessary to carry out the objectives of this ordinance.
- **SECTION 4.** *RULES AND REGULATIONS.* The Ministry of Basic Higher and Technical Education and the City Government of Cotabato shall promulgate the necessary rules and regulations relative to the provisions of this ordinance.
- **SECTION 5.** APPROPRIATIONS. The initial funding required for the implementation of this ordinance for the Calendar Year 2022 shall be sourced out from the Gender and Development Fund Integration of Culture of Peace & Equality in School and Out of School Education and the subsequent fundings for the succeeding years shall be included in the Annuâi Budget of the City Government of Cotabato.
- **SECTION 6. SEPARABILITY CLAUSE.** If, for any reason or reasons, any part of the provisions hereof shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.
- **SECTION 7.** REPEALING CLAUSE. All laws, decrees, orders, rules, and regulations or other issuances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed.
- **SECTION 8.** *EFFECTIVITY CLAUSE.* This ordinance shall take effect immediately upon its approval.
